

## Nomination

### for the election of a Fachschaftsvertretung 2025

#### Notes

1. The proponent and the nominees must have passive franchise in the election to the Fachschaftsvertretung for which this proposal is submitted. These are all members of the Fachschaft who are not on leave and who are not members of the Election Committee (Wahlausschuss) or the Election Standards Committee (Wahlprüfungsausschuss). Each student is a member of exactly one Fachschaft and is only entitled to vote in this council. Assignment to the Fachschaft is based on the first subject mentioned in the enrollment.
2. The nomination must include at least three nominees.
3. The election proposal should consider men and women equally. If this is not possible, the reasons for this must be explained (declaration of parity). It is therefore mandatory to state the gender of the nominee. The statements "non-binary" (divers) and "not specified" are also permissible. The information does not have to match the gender entry on the birth certificate.
4. With their declaration of consent the nominee declares their consent to the inclusion in this nomination.
5. Providing the telephone number and the e-mail address of the proponent is voluntary, but recommended to ensure quick reachability in case of questions. Providing the country of origin for the nominee is also voluntary, but will appear on the ballot. The remaining fields must be filled in. All fields must be filled in readable, ideally digitally.
6. The provided address may differ from the address given to the Studierendensekretariat. The home address or the address at the place of study may be provided. In case of inconsistencies the proponent should however be reachable on short notice by the election coordinator and the presidium of the student parliament respectively.
7. The subjects of the candidate and the proponent must be listed in the same order as on the Certificate of Student Status.
8. Submission is due at 17:00 on the 49<sup>th</sup> day before the election deadline. Missing information can be filed with the election coordinator until then.

#### Declarations of submission

There is no need for signatures in this document.

To confirm the inclusion in this list, a confirmation e-mail must be sent from the stu-mail of the nominee to the proponent.

This confirmation e-mail must be sent from the proponent to the election committee together with the signed submission form (Einreichungserklärung).
